Poštovani gospodine Camarata,

Više puta obraćali smo se delegaciji Evropske Unije i Vama (web site: www.upisigre.me, dokumenta 2012./13./14. : akt od 27.1.2012.; akt br.33 od 22.3.2012.; akt br.39 od 17.4.2012.; akt br.141 od 3.7.2013.; akt br. 191 od 18.9.2013.; akt br. 50 od 20.3.2014.; akt br. 56 od 29.4.2014.; akt br. 65 od 29.5.2014.; akt br.82 od 1.7.2014.; akt br 150 od 3.10.2014.) povodom problema sa kojima se suočavaju istaknuti predstavnici naše organizacije (NVO UPIS) i članovi naših familija, da na nivou sistema ostvarimo Ustavom zagarantovana prava i slobode i zaštitimo ljudsko dostojanstvo, pravo na privatnost, pravo na slobodu izražavanja i načelo jednakosti, odnosno zabrane diskriminacije.

Istovremeno, suočeni smo sa čitavom lepezom napada i hajke na nas od strane različitih aktera iz svih segmenata crnogorskog društva koji ne prezaju od zloupotrebe sopstvene uloge, na štetu uživanja naših prava i sloboda, putem različitih vidova etiketiranja i hajke, pa i putem zloupotrebe uloge civilnog društva, medija i Institucija u takve svrhe. Shvatamo da to nijesu evropske vrijednosti, te nas posebno uznemirava i zabrinjava kada takve i slične aktivnosti bivaju u kontinuitetu, tendenciozno i sa lošom namjerom kreirane od onih koji su i sa vaše strane podržani da zastupaju istinske evropske vrijednosti, što uvijek ili često puta i nije baš slučaj.

Zloupotreba takve uloge posljednjih mjeseci naročito dolazi od g-đe Daliborke Uljarević, koja na račun naše članice, pravnog subjekta Lutrije Crne Gore a.d. - TV 777 (1.250 akcionara, 350 zaposlenih) BEZ IKAKVOG osnova crta metu sa ciljem zamjene teza i pokušaja naše diskreditacije.

U prilogu ćete naći njenu izmišljenu izjavu, gdje napominjemo da TV 777, niti pravni subjekti, nikada pa ni u svojoj TV programskoj šemi, niti u bilo kom proizvedenom programu nikada i ni jednom nije pominjala, a kamoli se bavila aktivnostima gđe Uljarević i NVO Centra za građansko obrazovanje po njenim izmišljenim navodima (izjava u ND Vijesti, 6.avgust 2014. str.10, sadržaj pod naslovom "CGO sad goni Miloša Šoškića.....Preko Pobjede, Pinka M i TV 777 su mi javno sudili i crtali metu")

Sumnjamo da se pozadina ovakve njene izjave upravo nalazi u različitim interesima političke, finansijske i interesne grupacije koji već duže vremena, u kontinuitetu zloupotrebom uloge koju imaju, narušavaju koncept važnosti uloge i kvaliteta dijaloga koji civilno društvo i mediji donose svakoj zemlji.

Zbog toga, molimo Vas za moguću intervenciju tim povodom, posebno da ispitajte da li su ovakve aktivnosti i zloupotreba uloge medija i civilnog društva u slučaju manipulacije gospođe Uljarević, kao dio hajke protiv naše NVO organizacije, naših članica, prevashodno pravnog subjekta Lutrija Crne Gore i elektronskog medija TV 777, na bilo koji način finansirane iz fondova Evropske Komisije? **U tom slučaju, mi bi imali ozbiljan prigovor! Kakav je Vaš stav po gore navedenom?**

Subject: **Notification and demand**

Dear Mr Camarata,

We addressed several times European Union delegation and you (web site: www.upisigre.me, documents 2012/13/14 : Act 27 January 2012; Act No.33 dated 22 March 2012; Act No.39 dated 17 April 2012; Act No.141 dated 3 July 2013; Act No. 191 dated 18 September 2013; Act No.50 dated 20 March 2014; Act No. 56 dated 29 April 2014; Act No. 65 dated 29 May 2014; Act No.82 dated 1 July 2014; Act No. 150 dated 3 October 2014) regarding the problem faced by distinguished representatives of our organization (NGO UPIS) and our family members, striving to exercise our rights and freedoms provided by the Constitution, and to protect human dignity, right to privacy, right to freedom of speech and principle of equality and non-discrimination.

At the same time, we are facing series of attacks and hunt against us by various actors, from each segment of Montenegrin society, who have no qualms about abusing their own position to jeopardize our rights and freedoms through various types of our labelling, and through abuse of role of civil society, media and the Institutions for such purposes. We recognize that these are not European values, and we are particularly uneasy and concerned when such and similar activities have been created continuously, prejudicially and maliciously by those who have been supported by you to represent the true European values, which always or usually was not the case.

Abuse of such a role, in the recent months, has been done especially by Mrs. Daliborka Uljarević, who, on account of our member, a legal personality of Lottery of Montenegro, joint-stock company – TV 777 (which has **1,250** stockholders and **350** employees), GROUNDLESSLY draws the target with a view to inverse the arguments and to attempt to discredit us.

You will find in the attachment her fabricated statement, and here we want to point out that the legal personality and the TV777 in its programming schedule or any broadcast program have not mentioned or dealt with the activities of Mrs Uljarević and NGO Centre for Civic Education, as she incorrectly alleged (statement in the daily newspaper Vijesti, dated 6 August 2014 p.10, content under the heading: **“CCE now chases Miloš Šoškić.....Through Pobjeda, Pink M and TV 777, I was publicly prosecuted and targeted”**)

We suspect that the background of such statement is placed in the various interests of political, financial and interest group which, for a long time, with continuous abuse of their positions, has been violating the concept of importance of a role and quality of dialogue which the civic society and media bring to each country.


Therefore, we ask you for a possible intervention in this regard, especially to examine whether such activities and misuse of media and civic society, by the act of manipulation of Mrs Uljarević, which is the part of hunt against our NGO, our members, primarily against our legal personality of Lottery of Montenegro and electronic media TV 777, have been in any way funded by the European Commission? **In this case, we would have a serious complaint! What is your opinion on the above?**
