Poštovani gospodine Kamarata,

Zahvaljujemo na Vašem pismu. Cijenimo što ste uzeli u obzir pitanja koja smo pokrenuli. Štaviše, ovo nijesu samo pitanja, već ozbiljni problemi naše potpune obespravljenosti, nemogućnosti da ostvarimo komunikaciju sa nadležnim državnim organima (prije svega sa kancelarijom Zaštitnika ljudskih prava i sloboda Crne Gore), propuštanje nadležnih da upotrijebe zakonom propisana ovlašćenja, ponavljanje akta diskriminacije u Skupštini Crne Gore i pored izričite zabrane suda, nepostupanje u drugim slučajevima diskriminacije koji su u vezi sa istaknutim predstavnicima našeg Udruženja i članovima naših familija, ustupanje mjesta političkoj dominaciji na uštrb osnovnih ljudskih prava i sloboda i načela zabrane diskriminacije. Posebno, to je poprimilo razmjere da naši opisani problemi prevazilaze okvire ljudskih prava i suštinski zadiru u problematiku vladavine prava i garancija s tim u vezi, koje država treba da primijeni prema svim građanima jednako. Mi ćemo nastaviti da Vas informišemo o našem slučaju (slučajevima) i uskoro ćemo pripremiti novu/proširenu stručnu analizu našeg slučaja, slijedeći osnovna načela vladavine prava, ljudskih prava i sloboda i osnovnih postulata evropskih vrijednosti i načela.

S tim u vezi, ovim putem ponovo tražimo sastanak sa Vama, kako bi u neposrednom susretu dobili priliku da sistematski i detaljno predstavimo našu argumentaciju, dokaze i činjenice. Dozvolite da ovo shvatite kao konkretan doprinos važnosti vladavine prava i pravilnom funkcionisanju institucija kako ste nas informisali u Vašem pismu od 12 decembra 2014. Takođe, u potpunosti razumijemo i imamo u vidu nadležnosti Delegacije EU u Crnoj Gori i mi ćemo se toga pridržavati, na isti način kao što cijenimo i slijedimo Vaše dosadašnje savjete. U svemu tome, očekujemo da u čitavoj situaciji dobijemo s Vaše strane isti tretman kao mnoge druge nevladine organizacije u Crnoj Gori, koje održavaju kontakte i susrete sa Vama, posebno u situacijama kada su povrijeđena njihova osnovna ljudska prava i slobode. Cijenjećemo takav Vaš pristup.

Subject: Answer *Your letter from 12.th December 2014.*

Dear Mr. Cammarata,

We thank you on your letter. We appreciate your consideration of the questions you have raised. Moreover, these are not just questions, but serious problems concerning our complete deprivation of rights, inability to communicate with the competent state authorities (primarily with the office of the Protector of Human Rights and Freedoms of Montenegro), failure of the competent persons to use their power prescribed by law, the repetition of the act of discrimination in the Parliament of Montenegro despite the Court's explicit prohibition, failure to act in other cases concerning discrimination against the prominent representatives of our Association and members of our families, giving priority to political domination to the detriment of fundamental human rights and freedoms and the principle of non-discrimination. In particular, it became so large that our described problems exceed the scope of human rights and substantially went into the issue of the rule of law and guarantees in that respect, which must be applied by the State for all citizens equally. We will continue to inform you about our case (cases) and we will soon prepare a new/extended expert analysis of our case, following the basic principles of the rule of law, human rights and freedoms and basic postulates of European values and principles.

In this regard, hereby we again ask the meeting with you in order to have the possibility to present our argumentation, evidence and facts in immediate encounter, in a systematic and methodical way. We kindly ask you to understand this as a concrete contribution to the importance of rule of law and proper functioning of the institutions as you have informed us in your letter from 12 th December 2014. In addition, we completely comprehend and bear in mind the competence of the Delegation of the EU to Montenegro and we will adhere to that, in the same way as we have appreciated and followed your previous advice. In all this, we expect that in this situation we will get from you the same treatment as many other non-governmental organizations in Montenegro which have contacts and meetings with you, especially in situations when their basic human rights and freedoms are violated. We will appreciate such an approach.

In anticipation of your reply and our meeting, accept our warmest greetings.

P.S: We enclose the new address to the Protector of Human rights and Freedoms of Montenegro (hereinafter referred to as the Protector) no. 218 dated 25 December 2014, which is motivated by the fact that, to the present day, it was not acted upon our complaints, nor the competencies prescribed by law were applied. All this included the Protector's failure to act upon the two new discrimination complaints against the Protector no.179, no.180 and no.181 dated 26 November 2014, and the repeated act of discrimination committed in the presence of the Protector in the Parliament of Montenegro on 4 November 2014.
